You can apply for a preliminary hearing to determine specific matters before a final hearing, such as a legal question or whether a Cultural Heritage Management Plan is required for the application that is under VCAT review.

You **must** send a copy of this application to all other parties in the case.

VCAT may decide that a practice day hearing or preliminary hearing is needed without any request from parties in a case.
