WHAT VCAT CAN DO

Use this form if an order was made in your favour and you want VCAT to re-open the order to fix a problem with enforcing or complying with the order.

We may change the order or cancel (revoke) the order and make another order.

APPLICATION FEES

You must pay a fee if your application is heard in the Civil, Administrative or Planning and Environment Divisions. There is no application fee if your case is in the Residential Tenancies or Human Rights Divisions. VCAT fees are charged according to three levels:

- Corporate fees for businesses and companies with a turnover of more than \$200,000 in the previous financial year, corporate entities and government agencies
- Standard fees for individuals, not-for-profit organisations, and small businesses and companies with a turnover of less than \$200,000 in the previous financial year. Companies must provide a statutory declaration to support this claim
- Concession fees for people who hold the Australian Government Health Care Card. You must provide a copy of your card with your application.
