

VCAT is a tribunal that hears and decides civil and administrative legal cases in Victoria.

In most cases you have to pay a fee when you apply or use some of our services.

These fees are updated every year.

In this document, you can check the fees the Victorian Government has set for VCAT services effective from 1 July 2017.

Fee categories

In most cases you have to pay a fee when you apply to VCAT or use some VCAT services.

When you make an application tell us what type of fee payer you are and provide proof of your status.

We have three fee payer levels: Standard, Corporate and Health Care Card. The fee payer level applies to all the fees you are required to pay for the duration of the case until it is completed. You must apply separately for each case.

Health Care Card holders

You can pay a lower fee if you hold a current Health Care Card issued by the Federal Government.



The concession fee is capped at \$156.40 for each fee payable in your case for the period from 1 July 2017 to 30 June 2018. You can also apply for fee relief, go to: www.vcat.vic.gov.au/feerelief.

Other types of concession cards

If you hold another type of concession card, you can apply for fee relief to have fees waived or further reduced. You are not eligible to pay the Health Care Card fee.

Standard fee payers

Standard fee payers are defined as:

- individuals (including those who run small businesses as sole traders or in partnerships)
- not-for-profit organisations
- incorporated businesses with a turnover of less than \$200,000 in the previous financial year.

If your company wants to apply as a standard fee payer, you will need to provide a statutory declaration with your application that states this.

Corporate fee payers

Corporate fee payers are:

- businesses and companies with a turnover of more than \$200,000 in the previous financial year
- corporate entities and government agencies.

VCAT cases without application fees or hearing fees

There are no application fees or hearing fees for the following types of cases:

- Disability Act
- Health and Privacy
- Mental Health
- Powers of Attorney.

If the value of your matter is under \$15,001, hearing fees do not apply.

If the value of your matter is between \$15,001 and \$100,000, hearing fees do not apply on the first day of hearing, but apply for each following hearing day.

If you have a VicSmart application or a change in conditions application, hearing fees do not apply on the first day of hearing unless an objector application is also lodged, in which case the permit applicant must pay the hearing fee on the first day. Hearing fees apply for each subsequent hearing day.

Hearing fees apply from the first day of hearing if the value of your matter is over \$100,000, a non-monetary matter, a matter for an unspecified amount, a complex case or a major case.
